

Special Consideration Medical Impact (HE) Statement

Students who have been hampered by illness or other cause which has affected their capacity to prepare, present or perform any component of an assessment can apply for special consideration. This includes examinations, presentations and performance assessments that are scheduled at specific times/dates, and extension requests beyond 10 working days.

Guidelines for practitioners completing the Medical Impact Statement

Melbourne Polytechnic appreciates you taking the time to complete this statement. The information you provide will assist us to make a fair and reasonable decision to best support the student.

These guidelines have been provided to assist you, as a professional practitioner, to understand the purpose and use of Melbourne Polytechnic's Medical Impact Statement in the special consideration process.

The purpose of special consideration is to give a student, whose work for a particular piece of assessment has been hampered by illness or other cause from preparing/presenting or completing an assessment a further opportunity to demonstrate their ability.

Information for Students

1. Use of the Medical Impact Statement

This statement is part of the application process for submitting a special consideration request on **medical grounds**. It will allow Melbourne Polytechnic to determine the appropriate outcome based on the student's medical circumstances.

If you do not provide the information requested in this statement, Melbourne Polytechnic will be unable to ascertain the relevant medical circumstances affecting your ability to complete the assessment and apply a consistent and fair process to considering your request for special consideration.

The information you provide will be made available to relevant staff to carry out their duties in accordance with Melbourne Polytechnic's privacy policy.

2. What is special consideration granted for?

An application for special consideration may be granted to a student on the following grounds:

- That the student's work at any time during the academic year has to a substantial degree been hampered by illness or other cause;
- That the student has been prevented by a serious or disabling illness or other significant cause from preparing
 or presenting for all or part of a component of assessment; or

That the student was to a substantial degree adversely affected by illness or other cause during the performance of a component of assessment.

Melbourne Polytechnic has a variety of supports and services available for student with a disability or long-term medical or mental health condition. A student can register with Disability Support Services to develop a Disability Support Plan and access appropriate academic support via the Learning Skills and Assessment Unit. The Counselling Service provides assistance with anxiety, stress and wellbeing support.
